# **APROVAL OF MINUTES**

Tim motioned to approve the January 6, 2016 meeting minutes. Ray seconded the motion. Tim motioned to approve the February 25, 2015 meeting minutes. Seconded the motion. All of the council members agreed to both meeting minute approvals.

#### **INTRODUCTIONS OF NEW MEMBERS**

#### **EDUCATIONAL INSTITUTIONS DISCUSSION**

The council held a discussion about the education institutes that want to run the rivers themselves. It was decided that a small committee would be formed to talk about coming up with an idea, and way to approve these trips.

#### PROGRAM UPDATE

<u>Legislative:</u> Senate Bill 187 – Dropped the rest of the citable boating statutes down to an infraction. State Parks asked that they keep the navigation and steering laws at a class C, and the legislator kept them as a Class C.

<u>Pineview Swim Area</u>: Brody read an update from Robert Sanchez. The forest service will hold a meeting for this on April 12, 2016.

<u>Life Jacket Letter:</u> Brody shared a video of Brett Reed, a 6<sup>th</sup> Grader at HMK Elementary in Moab, UT. He sent Ty a letter about changing the rules of wearing a life jacket. Brody and Ty went down and presented him with a life jacket.

# **OTHER BUSINESS**

Salt Lake County wants to build a ramp.

## **AIS UPDATE**

Craig Walker discussed the progress that they are making in the decontamination of boats. They are going to split the program between the biology aspect, and keeping the boats clean. They have made plans to give more time to each program.

Discussed the need to work on state reciprocity and points that will be set up to contact boats needing to be decontaminated.

Boaters are requesting a more consistent standardized program to make it easier to get their boats decontaminated. Training will start around 4/20/2016 to train techs, up to 50 people at a time.

Craig talked about a tag that will be put on boats coming out of Lake Powell, and a way to track the boats in 2017.

Craig is going to look into getting the outfitter companies certified to self-inspect their vessels.

They are moving forward with privatization of large boats coming out of Lake Powell. There will also be a boating access satisfaction survey coming out in 2017.

The next meeting will be July 12, 2016, and will be a float trip down the Jordan River.
