

# MINOR - INFORMED CONSENT, WAIVER AND RELEASE AGREEMENT FOR JORDAN RIVER OFF HIGHWAY VEHICLE STATE PARK

The undersigned participant, being under the age of 18 years, hereby acknowledges the following for the calendar year 20\_\_:

I desire to use the Jordan River Off-Highway Vehicle State Park. I have been trained in the use of the Off Highway Vehicle (OHV) and have taken and passed a safety education course regarding the operation of the OHV. I understand that the use of off highway vehicles involves a high degree of physical activity and carries a risk of personal injury or property damage. I further recognize there are natural and manmade hazards, environmental conditions, diseases and other risks that in combination with my action(s) or the actions of others can cause injury to me or damage to my property. I agree that I will act in a safe and prudent manner to avoid these risks. I also acknowledge that I have familiarized myself with the course and what is required, will wear appropriate safety equipment, including a helmet. I will follow the rules of conduct, will follow the operating procedures and any directions given by an authorized person.

The Undersigned parent of legal guardian of the minor participant (hereinafter "participant"), in consideration of the participants usage of the course does hereby agree to this waiver and release for the calendar year 20\_\_.

I recognize the use of the course involves moderate to strenuous physical activity and may cause physical and/or emotional distress to participants. There may also be associated health risks. I state that the participant is free from any known heart, respiratory or other health problems that could prevent the participant from safely participating in any of the activities. I certify that I have medical insurance or otherwise agree to be personally responsible for costs of any emergency or other medical care the participant receives. I agree to release the State of Utah and its agencies, departments, officers, employees, agents and volunteers from the cost of any medical care the participant receives as a result of usage of the course.

I further agree to release the State of Utah, its agencies, departments, officers, employees, agents and all sponsors, officials and staff or volunteers from any and all liability. Claims, demands, breach of warranty, negligence, actions and causes of actions whatsoever for any loss, claim, injury, illness, attorneys fees or harm of any kind or nature to participant arising out of participant's usage of the facilities. This release to any claim made by parents or guardians or their assigns arising from or in any way connected with the aforementioned activities.

## CONSENT

Consent is expressly given, in the event of injury, for any emergency aid, anesthesia and/or operation, if in the opinion of the attending physician, such treatment is necessary. We (the minor and parent/Guardian) have carefully read and understood the contents of the foregoing language, have been given a copy of the terms, and specifically intend it to cover the participation of participant at the Jordan River Off Highway State Park sponsored by the Utah Division of Parks and Recreation.
