The application fee to be on the boat slip waiting list is \$85 per year per slip pool (\$75 for Utah residents).

The waiting list is valid from May 1 through April 30 of the following year.

A waiting list applicant must renew their application on or before April 30 to retain their respective rank order on the waiting list for the coming year.

The name on this application will be the name transferred to the boat slip rental permit. This name shall also be listed on the certificate of registration for the boat.

Upon signing this application, the undersigned applicant acknowledges that they have fully read and understands the information on this application and the waiting list rules on the reverse side of this form.

## BOAT SLIP and WAITING LIST RULES

1. A boat moored in a slip shall not exceed the overall length and width requirements of the slip size. For the purposes of mooring a boat in the, the actual length of a boat may not be the length listed on the boat's certificate of registration. The measurement of the overall length of a boat must include all extensions from the bow, i.e. bow pulpits, to the stern, e.g. swim platforms, trolling motors, etc.
2. A boat slip rental permit shall not be in the name of a business. If the boat is registered to a family trust, the applicant must provide evidence they are listed in the trust.
3. Ownership of a boat is not required when applying for the boat slip waiting list.
4. All boat slip waiting list application fees are non-refundable, non-transferable, and non-applicable towards the payment of boat slip rental fees.
5. A boat slip waiting list applicant must be at least 18 years of age.
6. Applicants will be placed on the respective boat slip waiting list in a numerical descending order according to the date their original application was received and based upon continued renewal of their boat slip waiting list application.
7. When a vacancy occurs for a boat slip to be filled from the waiting list, Bear Lake State Park staff will attempt to notify the applicant at the top of the respective waiting list via phone and email one time. When contact is made, the applicant will have three (3) business days from the time of contact to accept or decline the offer to rent a slip. Contact is considered to have been made with a message left on an answering device or an email has been sent.

If contact is made with the applicant and they do not accept the offer, the applicant will have the opportunity to remain, in position, on the respective waiting list. If contact is not made with the applicant within three (3) business days, they will have the opportunity to remain, in position on the waiting list and the next person on the waiting list will be notified.

8. Applicants who accept an offer to rent a slip will be provided a dated Boat Slip Rental Permit. The applicant will have 30 days to provide the completed and signed Boat Slip Rental Permit, a copy of the boat's current Utah certificate of registration, and payment of the annual slip rental fees to the Bear Lake State Park office. The applicant will be assigned a specific boat slip once all required documentation and paperwork have been received by Bear Lake State Park.

Failure to meet this deadline will result in the applicant losing the opportunity to rent a slip and the next applicant on the waiting list will be called. The applicant will have the opportunity to remain, in position, on the waiting list.

9. Current boat slip renters who desire to rent a different sized boat slip will be required to submit a boat slip waiting list application for the respective size slip. Current boat slip renters who moor a boat that exceeds the size requirements of their assigned slip will be required to remove the boat from the marina and their current boat slip lease will be terminated.
