

# Park Guidelines

Please observe the following park regulations to ensure everyone's visit is pleasant.

**Glass is NOT ALLOWED in Sand Hollow State Park. Please do not litter.**

**Pets** — Pets must be leashed and under control at all times. Please clean up after your pet.

**Quiet Hours** — 10 p.m. to 6 a.m. Please turn off generators and music.

**Fires** — Campfires are allowed only in designated fire rings. Do not leave fires unattended. **Be aware of fire restrictions!**

**Firearms** — The use of firearms, traps, or any devices capable of launching projectiles that can harm people, animals, or property is strictly prohibited. For more information, please contact a park ranger.

**Fireworks** — Explosives, fireworks, or firecrackers are prohibited unless authorized by the park manager.

**Plants and Animals** — All plants, animals, minerals, and other natural features within state parks are protected. It is illegal to remove, alter, or destroy them.

**Campsites** — Camping is allowed only in designated campsites. Campsite fees cover one vehicle and any attached recreational equipment. There is an extra fee for additional vehicles or camping equipment. Up to eight people are allowed on a campsite. A permit is required for boat camping.

**Special Use Permit** — To use Sand Hollow State Park for special events, commercial or professional filming, photography (including YouTube videos), or any business-related activities that generate revenue, a Special Use Permit is required. Inquire in the Visitor's Center.

**Climbing**— Climbing on rocks, jumping, and/or diving from rocks is hazardous. Do so at your own risk.

**Glass**— No glass bottles or containers on the beaches.

**Off-Highway Vehicles**— OHVs are not permitted on any vegetation/dirt in the campgrounds and not permitted on some of the beaches within the park.

**Please DO NOT tread on vegetation.**

**Parking**— Park in designated areas only.

**Vandalism**— It is unlawful to mutilate or deface any natural or constructed feature or structure.



**Your park fees provide for the care, protection, and enhancement of this park.**

November - Daylight Savings 7 a.m. to 9 p.m.

## Park Location:

From I-15 take Hurricane Exit 16, then travel five miles east on State Road 9. Turn right on Sand Hollow Road and drive three miles to the park entrance.

# Sand Hollow State Park



Utah State Parks

With its warm, blue waters and red sandstone landscape, Sand Hollow State Park provides recreation opportunities for nearly every visitor, from boaters and off-highway vehicle (OHV) riders, to triathletes. Boat and fish on Sand Hollow Reservoir, explore and ride the dunes of Sand Mountain on an OHV, then RV or tent camp in one of the campgrounds.



**History**

Completed in April 2003, Sand Hollow Reservoir was created by the Washington County Water Conservancy District as additional water storage for Washington County. Used as culinary water by cities and towns in southwestern Utah, Sand Hollow Reservoir serves as an important water source in this otherwise hot and arid part of Utah.

**Camping**

Westside campground offers full hookups with water, sewer, electricity, barbecues, firepits, and covered picnic areas at each site. Restrooms and showers are available.

Sandpit campground offers 6 partial hookups with water, electricity, and barbecue firepits. Sandpit also offers 5 large group sites with picnic tables and fire pits and 19 dry camping sites. Restrooms and showers are available for Sandpit campers.

Lakeview campground offers full and partial hookups with water, sewer, electricity, barbecue firepits, and picnic areas at each site. Restrooms and showers are available for all Lakeview campers.

The Primitive campground offers disperse camping on the east side of the lake after the Lakeview side campground. CXT's available and lakeside views. Fires are prohibited in the sand, surrounded by rocks, or any other material that is **NOT** in an approved fire pit.

Beachside Cottages offers modern comfort for up to six people right on the banks of Sand Hollow Lake. Also, included is a full hook-up site for an RV.



**Obey Boating Laws and Rules**

- Invasive Species: All boats must be inspected prior to launching.
- Navigate at wake-less speed within 150 feet of boats, shorelines, swimmers, and paddle craft. Please observe waterway markers.
- Personal watercraft (PWC) may operate between sunrise and sunset.
- Lifejackets required for children 12 and under.
- One life jacket for each passenger on board.
- Life jackets are required for all PWC riders.

**Sand Mountain**

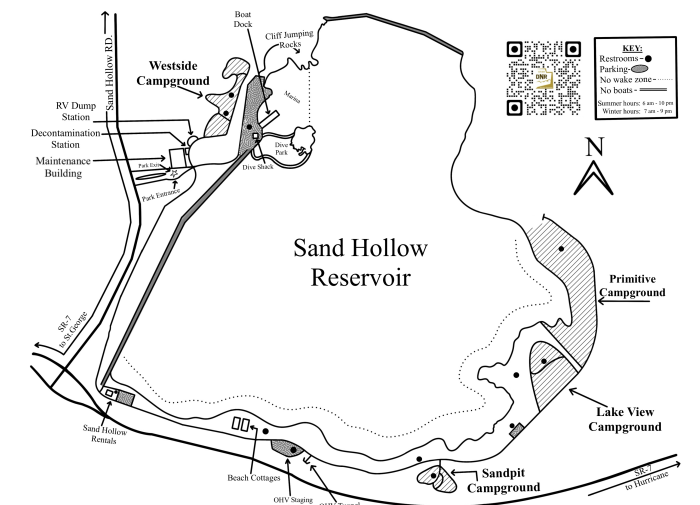
Off-highway vehicle riding is allowed on the south and east sides of the reservoir. Sand Mountain, which is accessed by a tunnel located south of the OHV staging area, offers 20,000 acres of prime OHV riding.

**Wildlife**

Many species call Sand Hollow home including, coyotes, foxes, rabbits, a variety of desert snakes, scorpions, lizards, and bugs. Be aware. In the heat of summer, the sand on the beaches can heat up to 100 degrees. Be cautious of your children and your pets.

**Are You Ready To Ride?**

- D.O.T. approved helmets are required for riders under age 18 and are strongly recommended for all riders.
- Whip flags are required on all motorized vehicles in the sand dunes.
- All Off-Highway Vehicles (OHVs) are required to have and display current Utah registration.
- OHV Safety Course is required for all operators.
